- (4) This award was granted on September 25, 2022. 12.5% of the award vested on April 15, 2023 and the remaining restricted stock units vest 12.5% in semi-annual installments over the four-year period ending October 15, 2026, subject to the terms and conditions of the underlying award agreement.
- (5) This award was granted on October 1, 2023. 12.5% of the award vested on April 15, 2024 and the remaining restricted stock units vest 12.5% in semi-annual installments over the four-year period ending October 15, 2027, subject to the terms and conditions of the underlying award agreement.
- (6) This award was granted on September 29, 2024. 12.5% of the award vested on April 15, 2025 and the remaining restricted stock units vest 12.5% in semi-annual installments over the four-year period ending October 15, 2028, subject to the terms and conditions of the underlying award agreement.
